## ANNOUNCEMENT ON

## THE NEW TRAVEL CONDITIONS AND THE IMPLEMENTATION OF HEALTH AND TOURISM SAFETY MEASURES FOR TRAVELLERS ENTERING CAMBODIA IN THE CONTEXT OF "A NEW NORMAL"

With reference to the announcement No. 504 dated 16<sup>th</sup> November 2021 of the Ministry of Health and Inter-Ministerial Commission to Combat Covid-19, the Ministry of Tourism of the Kingdom of Cambodia has the great honor to inform tourism associations, private sector, international tourists and travelers the new travel conditions and the implementation of health and tourism safety measures for travelers entering Cambodia in the context of "A New Normal" as follows:

- 1) International tourists and travelers who have been fully COVID-19 vaccinated should be accompanied by a COVID-19 vaccination certificate or certificate confirming their full COVID-19 vaccination and a negative COVID-19 certificate (PCR test) 72 hours prior to arrival in Cambodia, recognized by the health authority of their country or the last country before leaving for Cambodia. A COVID-19 Rapid Test will be administered upon arrival at Cambodian international gateways. If the Covid-19 test result shown negative, they are not required to undertake any quarantine and can travel freely throughout Cambodia. If the test shown a positive, they will be referred for treatment at the designated place authorized by the Ministry of Health.
- 2) For non-vaccinated or not fully COVID-19 vaccinated international tourists and travelers, a mandatory COVID-19 rapid test will be administered at the entrance to the country. If test shown a negative result, international tourists and travelers are required to undertake the quarantine for 14 days at a designated place authorized by the Ministry of Health or the competent authority, and will take a PCR test on day 13 of the 14-day quarantine. If test shown a positive, they will be referred for treatment at the designated place authorized by the Ministry of Health. International tourists and travelers are required to have a hotel reservation documents for the quarantine. In case of no booking, the international tourists and travelers must prepare cash of US \$ 2,000 (for foreign travelers) to be deposited at the entrance to Cambodia to ensure all expenses related to quarantine.
- 3) In case international tourists and travelers need a visa for traveling to Cambodia, they must apply for a valid visa in accordance with the procedures of the Immigration Law from the Cambodian Embassy or the Cambodian Consulate General. Visa applications must be made prior to departure to Cambodia, as the Royal Government of Cambodia has not yet approved for Visa on Arrival. International tourists and travelers holding visa exemption passport can travel to Cambodia without applying for a visa.
- 4) The Covid-19 treatment responsibilities for international travelers:
  - 4.1. For all foreign travelers (except diplomats, official cooperative project implementation officers holding diplomatic passports (Visa A) and official passports (Visa B) and their family members) are responsible for their own treatment if contracted with Covid-19 or other pathogens.
  - 4.2. All foreign travelers are encouraged to purchase COVID-19 Health Insurance. In Cambodia, international tourists and travelers can purchase Insurance Consortium represented by Forte Insurance Company, the company representing the joint insurance via website https://www.foteinsurance.com/covid-19-insurance/.

5) For the fully COVID-19 vaccinated international tourists and travelers, who are currently in quarantine centers, hotels, and homes nationwide, are allowed to stop quarantining if the Covid-19 test result is negative.

Upon receiving this announcement, Cambodia – Kingdom of Wonder warmly welcomes international tourists and travelers to the Kingdom of Cambodia with joy and excitement.
